



Kish Bank Promotes Four Mifflin County Associates

Decker's career at Kish started in October 2006 as Branch Manager for the Gateway branch in Reedsville. She then moved to Operations as the Business Service Support Manager, and was promoted into the Bank Secrecy Act/Fraud department. Terra's previous work with financial institutions has allowed her to grow with Kish, as well as to assume increasing responsibility in keeping abreast of complex regulatory requirements under the Bank Secrecy Act.
